

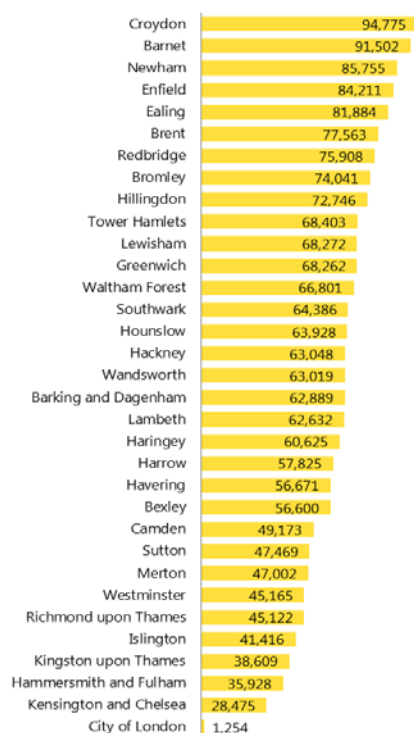

(mid-2017 estimates) by local authority

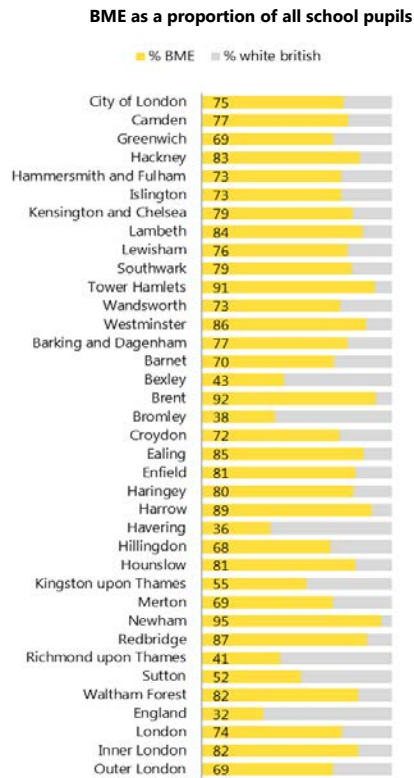

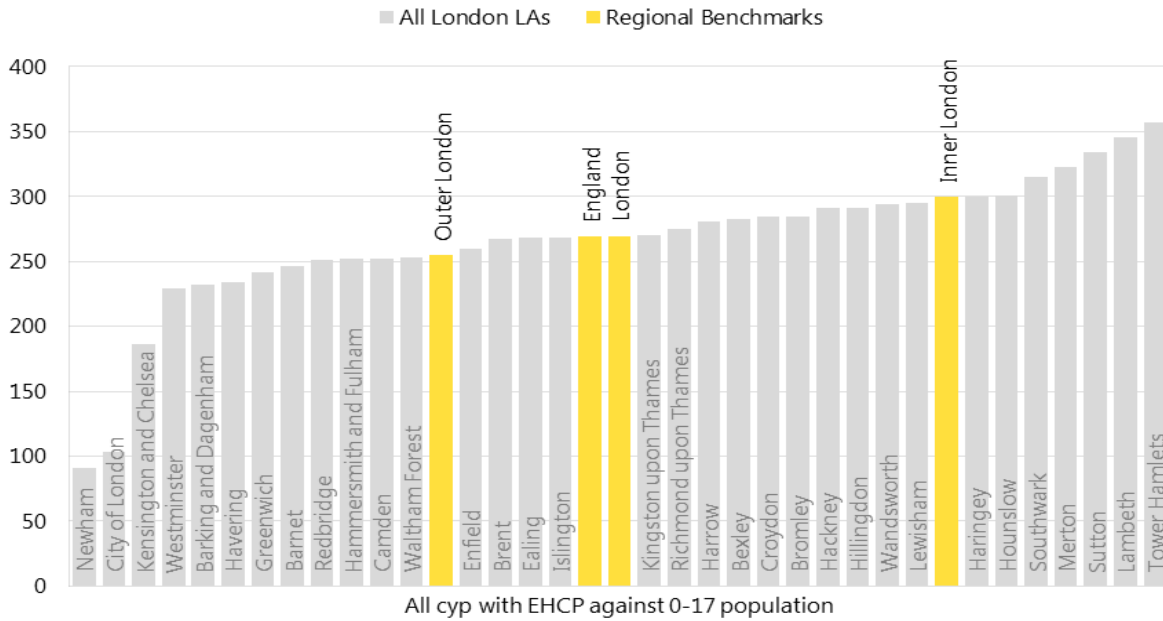

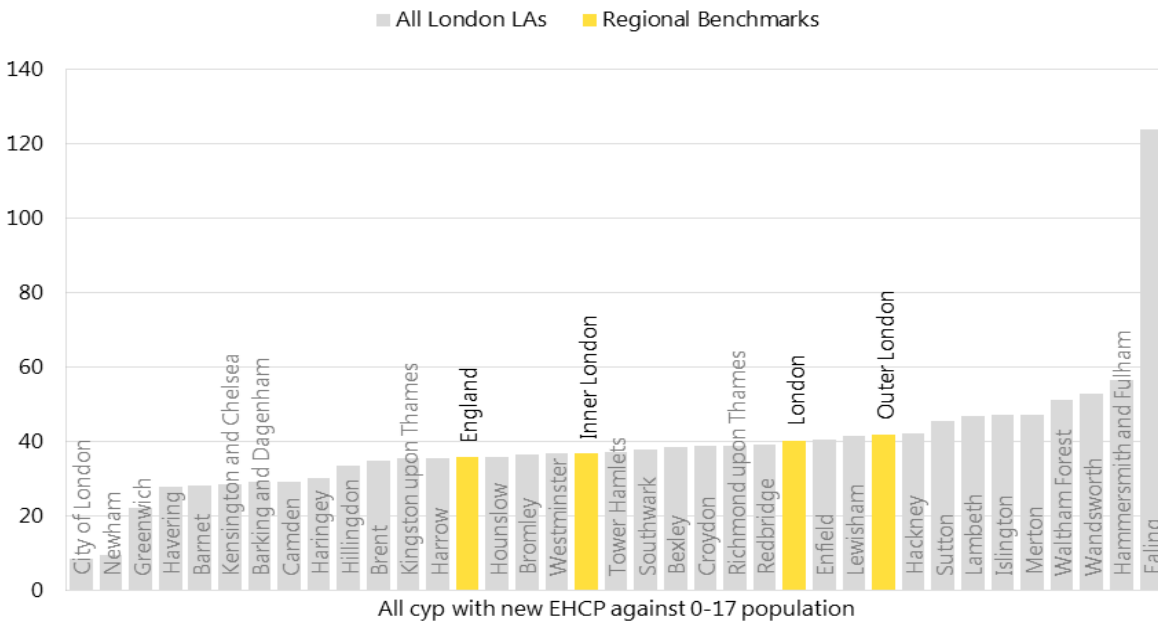

**new EHCP starting in the year to January 2018

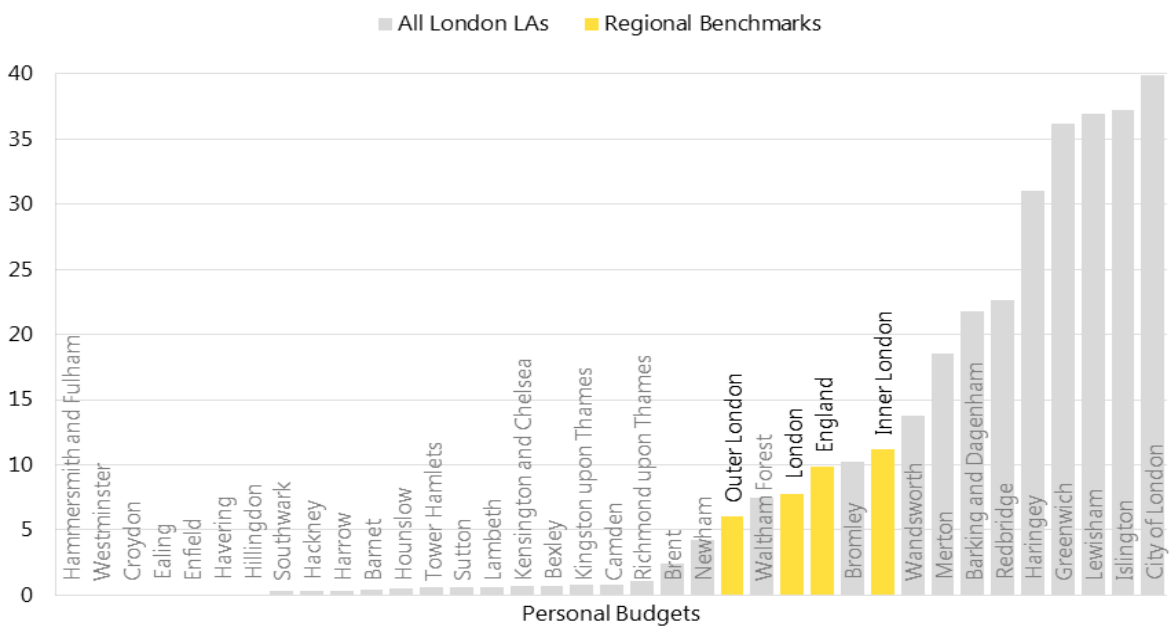

Number of Personal Budgets taken up during the year

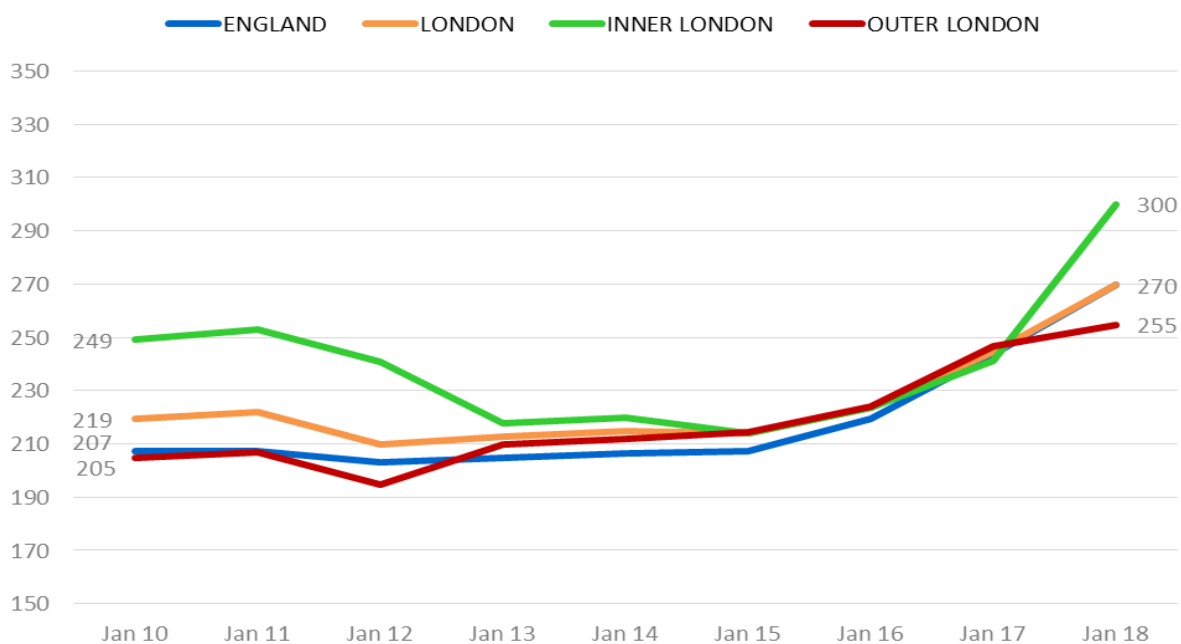

Rate of EHCP & Statements regional trends

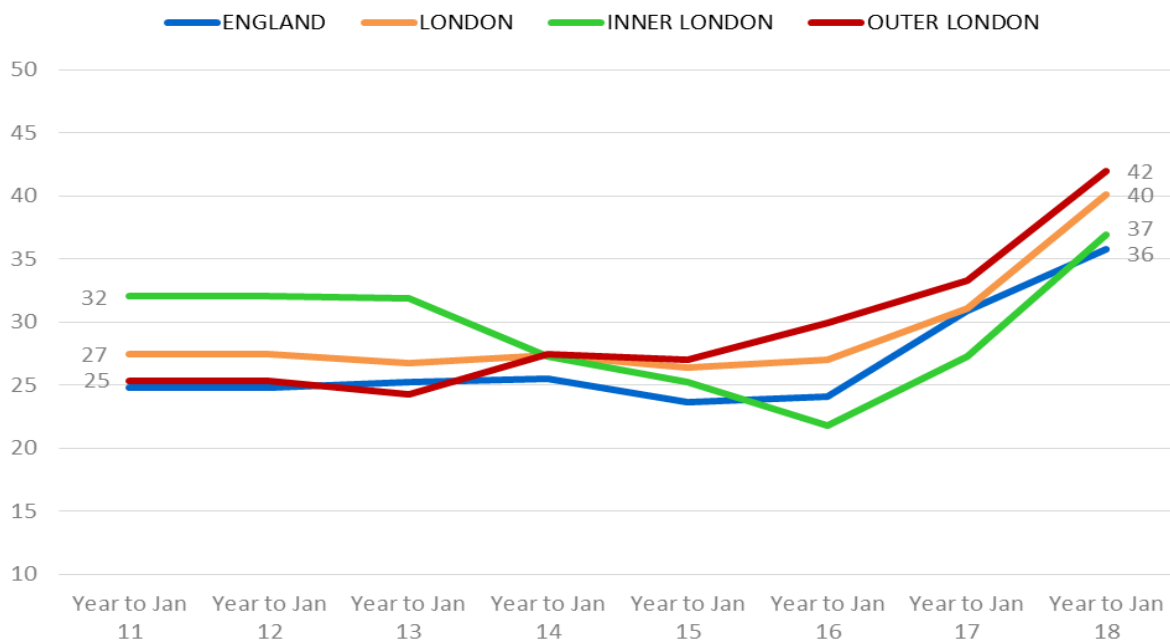

Rate of new EHCP & Statements regional trends

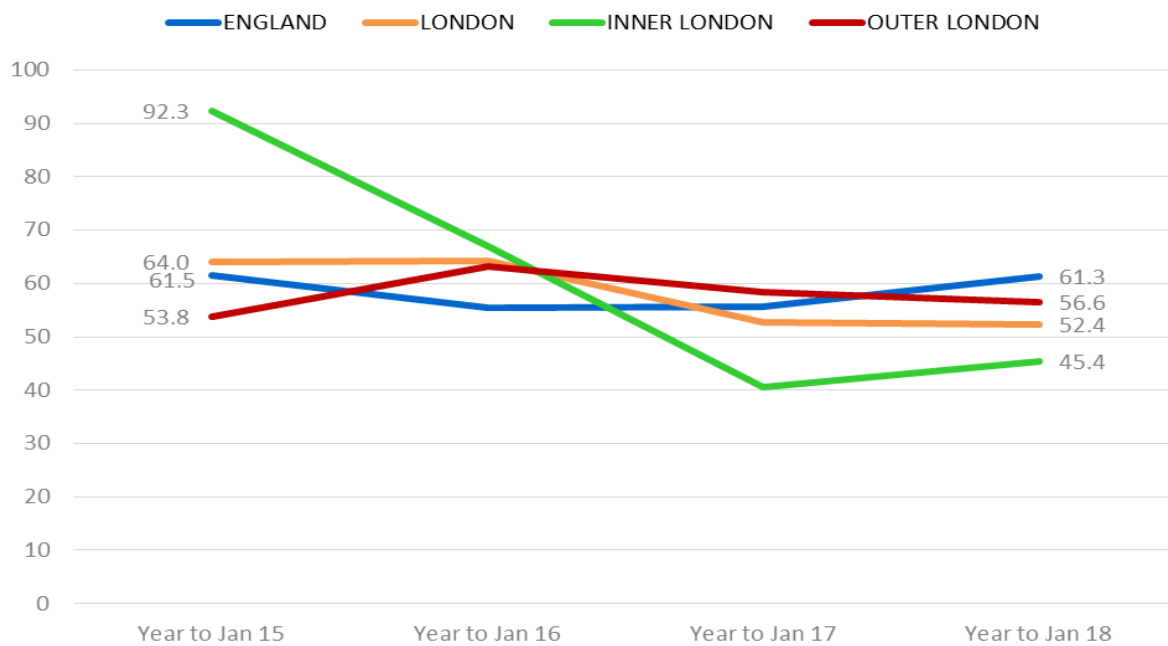

Percentage of EHCP completed within 20 weeks

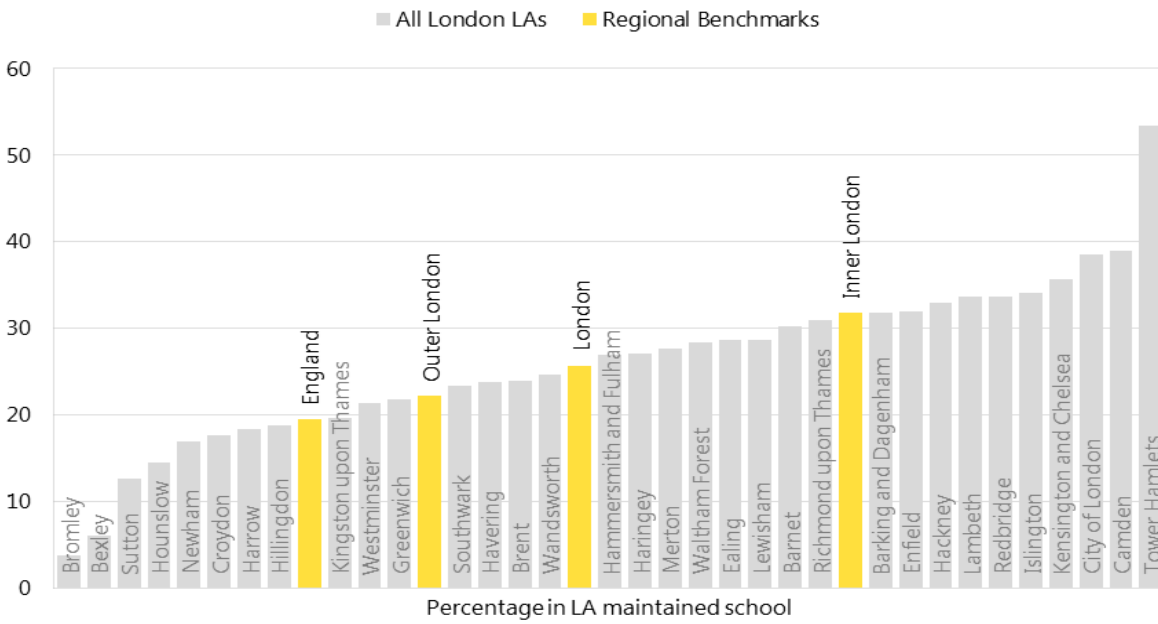

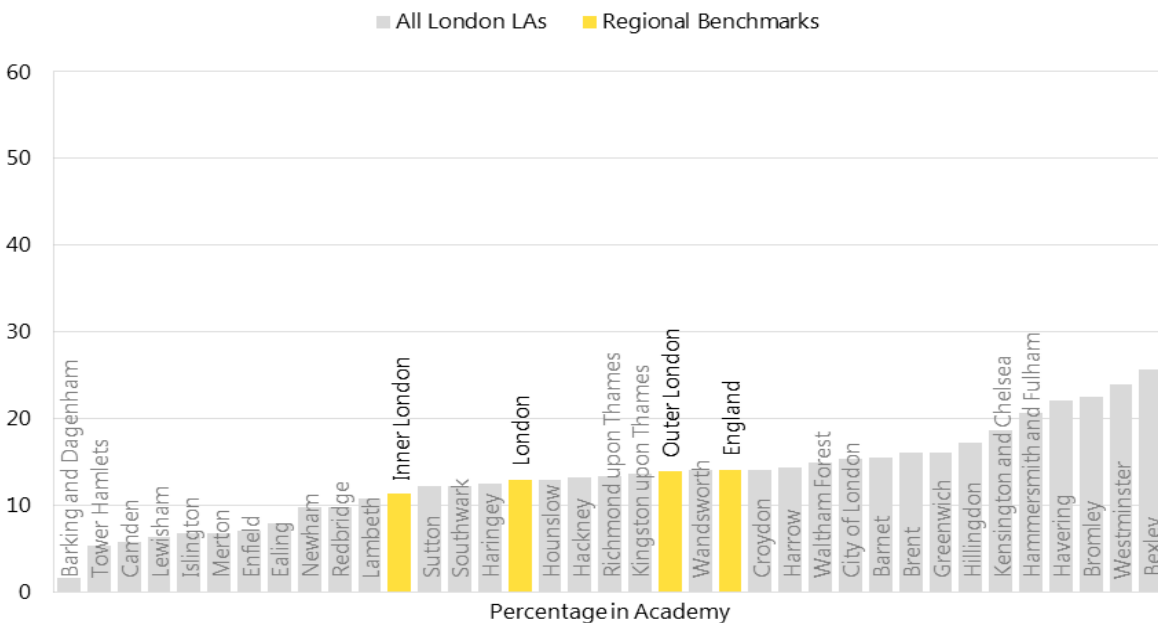

Percentage of children with EHCP in LA maintained mainstream school



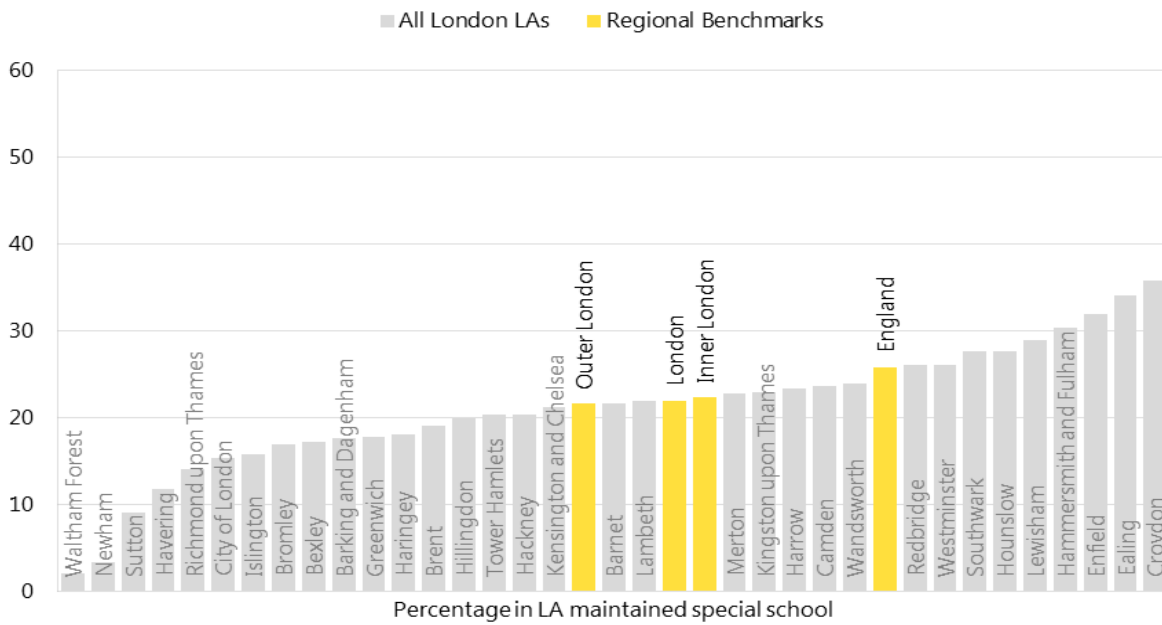

Percentage of children with EHCP in mainstream Academy school



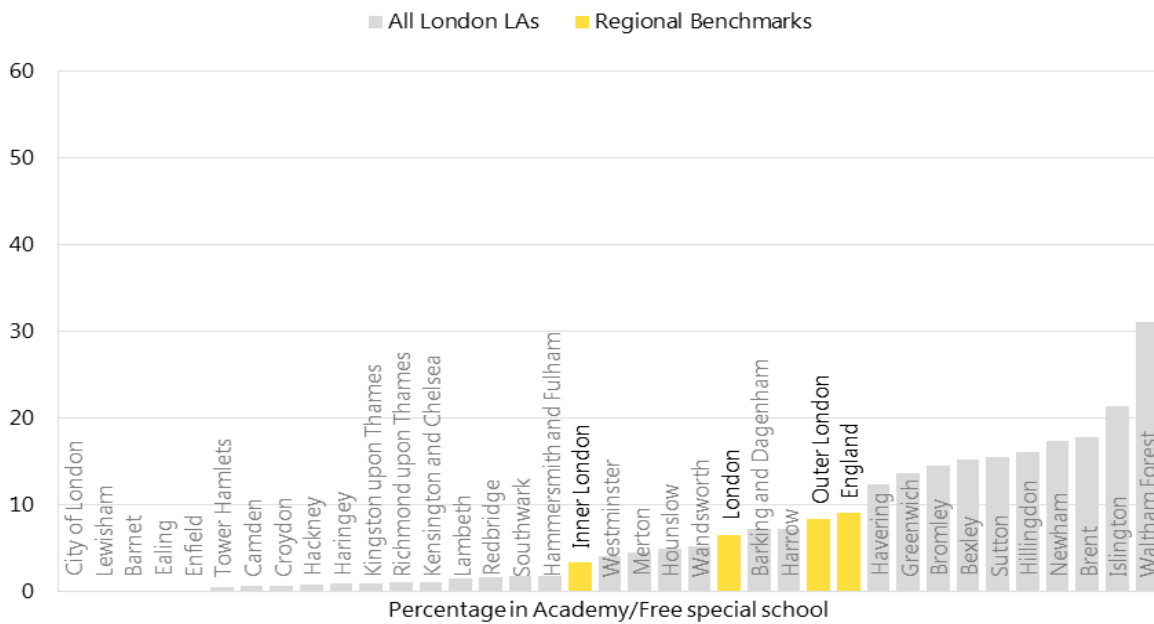

Percentage of children with EHCP in LA maintained special school



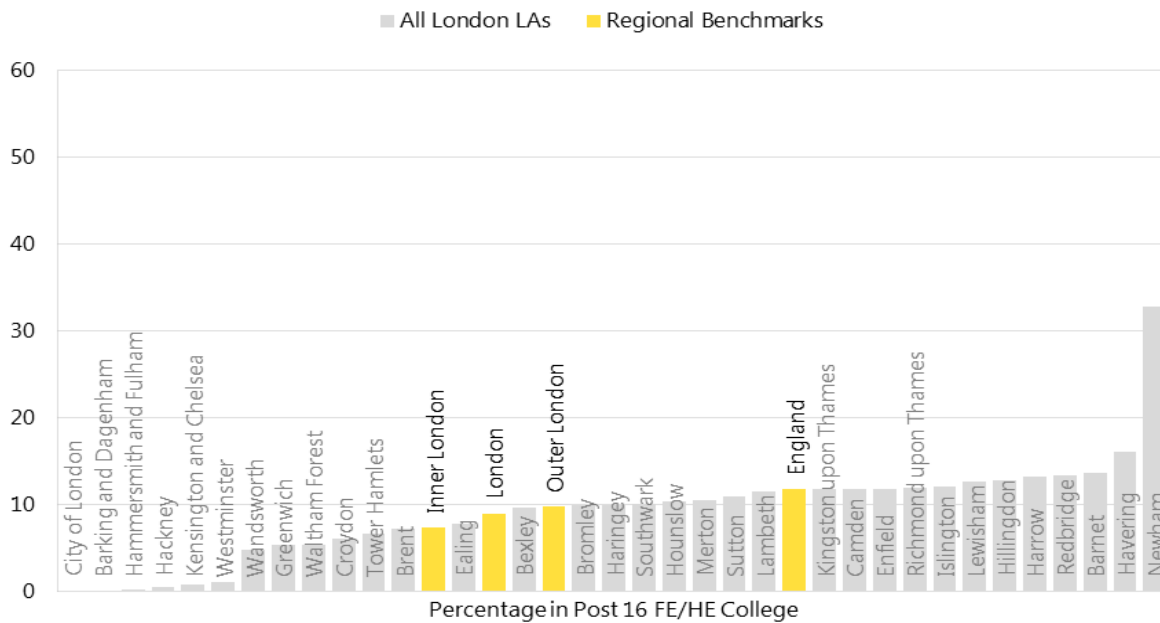

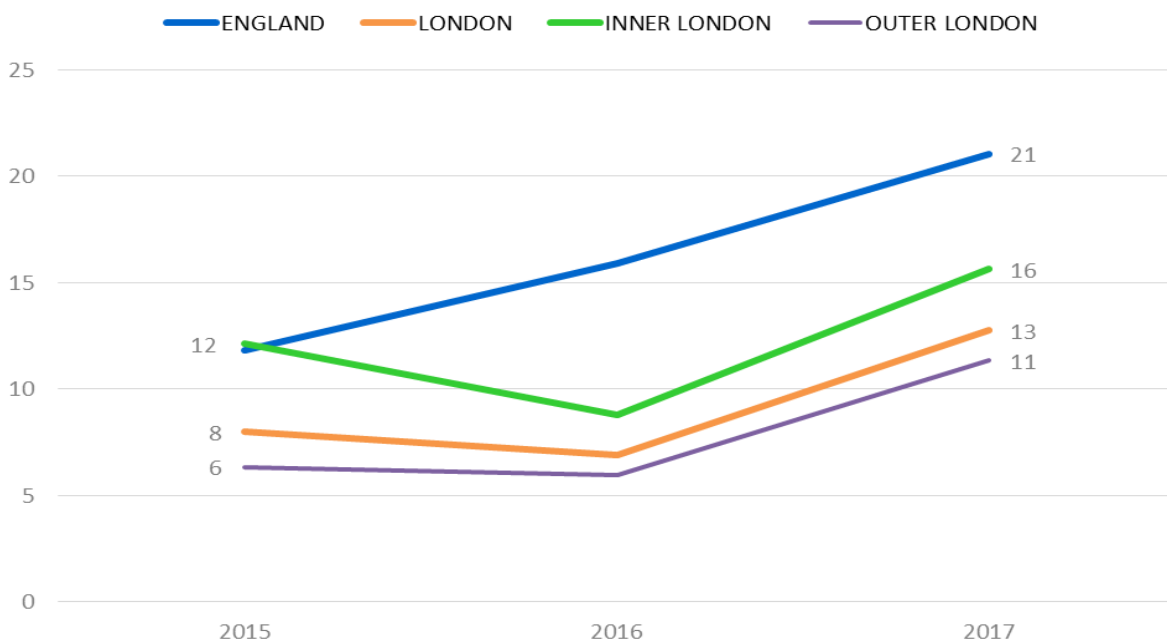
Percentage of children with EHCP in Post 16 FE/HE College

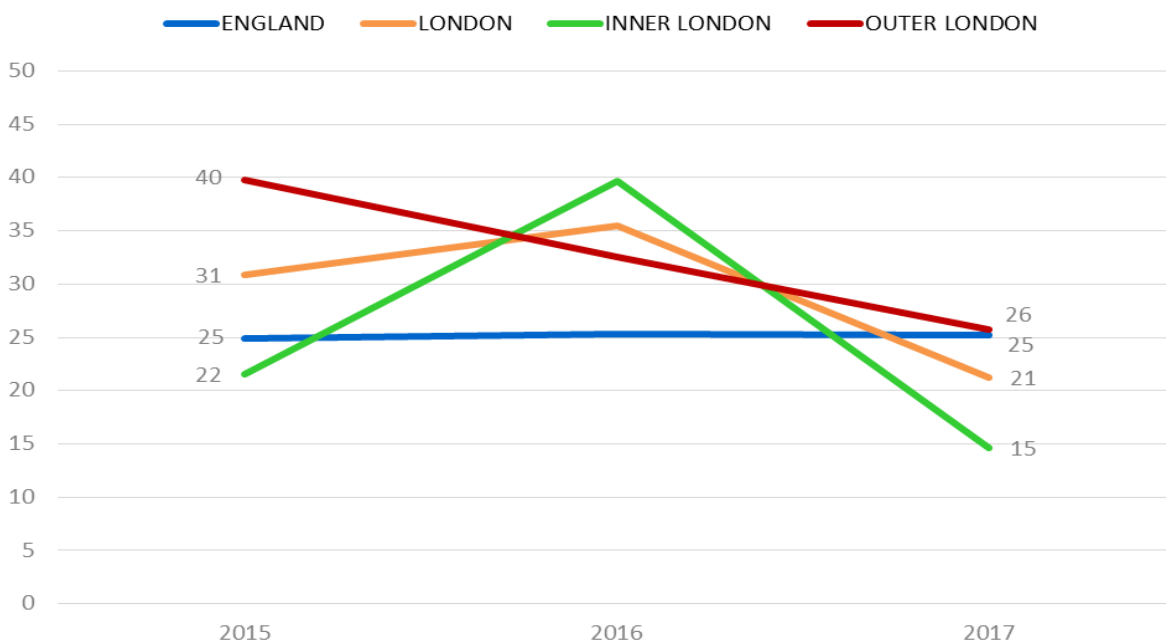
Rate of mediation cases held during the year

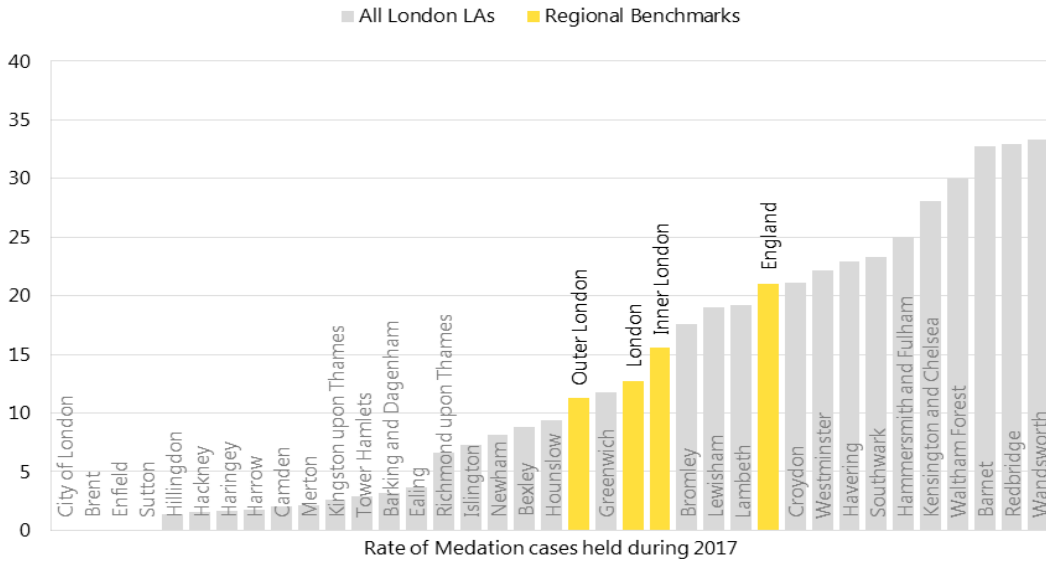
Percentage of mediation cases which were followed by appeals to the tribunal during the year

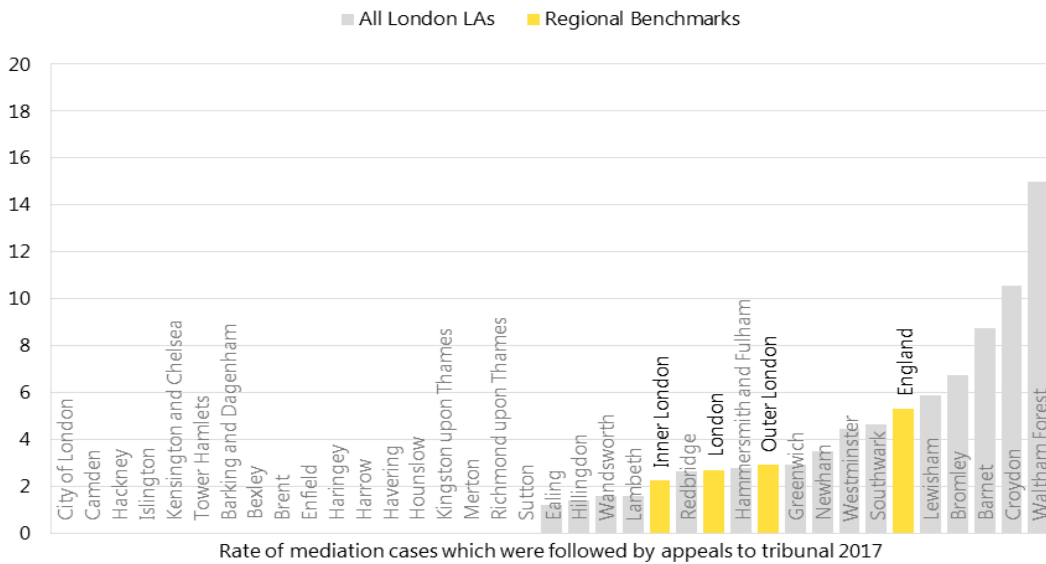

Notes and background information

Data source for analysis

Data is from the Department for Education Sfr publications - January 2018. Other official statistics have been used in the Demographics section.

Purpose of analysis

To provide London boroughs with a 'visual' view of the SEN 2 return for use in the Regional Improvement Alliance Sector-led Improvement work. It is intended to complement other forms of reporting.

Sharing the analysis

This report uses published data. It provides different views of this data to that already available.

London averages for 2017-18

The averages shown are num/denom calculations.

Rates per 10,000

All rates are shown as per a population of 10,000 children and young people aged 0-17 using the mid-2017 (2017-18) ONS estimates. For the Mediation/ Tribunal graphs a rate per 100,000 has been used to enable whole numbers to be used in the comparisons.

Definitions

- **Ethnicity:** This data comes from school census publications. '**Ethnic breakdown of pupils**' uses the five main ethnicity categories, in use across DfE publications for Education, Children's Social Care and other areas. 'White' in this context includes 'sub-categories' such as white European (& other similar 'white categories'). '**BME as a proportion**' simplifies this to 'BME', that includes the other 'white' categories, compared with 'white british'. This can make it seem as if the data is contradictory. The reason for including 'other white' categories in BME is because they may have needs in addition to what you might expect for children & young people who are 'White British'. If more detail is required then it would be worth using the School census publications for the full information.
